- Pierce (Demo)
  - o Availability: December 2025
  - Estimated Cost: ~\$625,000
  - Freightliner chassis
  - o Only demo currently available in the near term.
- BME
  - Status: No current units in the queue
  - Waiting on response from Wayne regarding next available build and pricing
  - We looked at this model previously and liked it.
- Ikon
  - Demo Unit
    - To be completed later this year
    - Current spec cost: \$529,298
    - Built on International chassis
  - Custom Build Option
    - Estimated lead time: 600 days
    - Estimated cost: ~\$650,000
    - 500 GPM pump, 500-gallon tank
    - Would serve as our back-up Type-1
    - We would want to add a turret

- Email Retention Policy
  - SDA guidance recommends following the policy based on the specific type of record:
    - "General Administration" records are kept for 1 year
    - "Housekeeping" records are kept as needed
  - Automated deletion may be challenging because everyone uses different email clients and checks their emails in different ways. Once an email is pulled off the mail server, there is no control over it.
  - A question was posed about whether we need to update our policy to state that emails shall be retained for one year. It could be challenging to apply a blanket retention period for all emails. If you have a defined policy, you must abide by it strictly. The policy could potentially be amended to state that all email is considered general administration and therefore not retained.

## **Ops/Training**

• We plan to use the DFPC Community Risk Reduction (CRR) education trailer provided by the state this year for fire prevention outreach at the Kremmling schools. This interactive semi-trailer is a new tool designed for community risk reduction, and we are exploring how best to incorporate it into our prevention training.

#### **New Business**

- NFIRS will be phased out over the next 18 months and replaced by NERIS. Colorado will begin the transition in November, with full implementation starting in 2026. All runs will be entered through NERIS at that time. The software we purchased is already compatible, and no issues are anticipated the RMS is ready.
- The Treasure Hunt has three badges hidden throughout town for the public to find. We ran this program a few years ago, and it was well received. It appears to remain a well-liked and engaging outreach activity.

## **DISTRICT COVERAGE**

#### **OLD BUSINESS**

• We need to stay on top of Jen from the Town of Kremmling regarding the IGA and the fire department water agreement.

### **NEW BUSINESS**

- Colorado Wildfire Resiliency Code
  - Two years ago, the State Legislature determined that a code-based approach was needed for wildfire prevention. As a result, the Colorado Wildfire Resiliency Code went into effect on July 1, 2025, with substantial enforcement beginning July 1, 2026.
  - The code includes requirements such as the use of fire-resistant materials in new construction and/or maintaining a 50-foot defensible space around structures.
  - At this time, it is unclear whether enforcement responsibility will fall to local agencies like ours. Hassler is attending the state's monthly peer group meetings and is going to the SDA conference next month to gain a better understanding of how these requirements will be implemented and what will be expected of us.
- Fire Code Adoption
  - The reason behind adopting the fire code was to be able to incentivize organizations with faulty fire
    protection systems to correct problems by the use of fees. We are relying on the county and state to inspect
    new construction and make sure the building is compliant.
