Moving forward with the tactical tender project, Brady and Tony looked at one in Gypsum from a vendor we are not familiar with. Waiting on sales people for more information.

Wildland rigs are ready and have been tested for the season.

Wildland training is scheduled for all of this month and some in June.

We are having problems getting the new foam to prime. We replaced a check valve hoping that fixes the issue.

A big part of district coverage is realizing how important tenders are.

It might be something to consider having discussions with Blue Valley about their hydrants. Need to discuss if they have been testing their hydrants. We need to find out what their flows are. Need to find out the waterline size going to the hydrants.

OLD BUSINESS

The town board seemed receptive to adopting the IFC when it was presented to them at their workshop meeting. They will need to hold a public hearing prior to adoption so it will take time for the publication and adoption.

We need the town to adopt the fire code in order to be able to enforce fines.

We need to work on educating businesses with alarms about what they can and cannot do when their alarm panel goes off. Businesses then need to educate their staff.

FedEx is very close to signing off on their sprinkler system. We still do not have a hydrant to supply the system. KFPD asked for a few more pull stations.

Anytime there is a new permit for a sprinkler system the KFPD should be notified.

The county is still interested in the Old Park Substation to store their vehicles. The district no longer has any use for the building except for storage. The board discussed the possibility of working with the county on a trade of the Substation for land that the county owns next to the district land in town so that we could build a storage building here to accommodate what is now being stored in Old Park.

Eggers requested a site plan of the district land to see if we have space for another storage building. The site plan will hopefully show the county owned land next to the district land. A formal survey might be required.

We need to contact the county to get the site plan from the tower.
